The Nassau County Mobile Crisis Team is a unit comprised of clinical experts who provide on-site intervention and evaluation for community members and their families. The crisis team provides assessment and referrals to appropriate resources. Examples of services are screening, assessment, stabilization, triage, and/or referral to an appropriate program or programs. The mobile crisis team also can work with the police to arrange for the transport of a person to the hospital if needed.

Nassau University Medical Center Psychiatric Emergency Room 2201 Hempstead Turnpike East Meadow, NY 11554 516-572-4775

A self-contained emergency room in Nassau County ready to care for those in crisis. The Psychiatric Emergency Department is fully staffed, and open for referrals 24 hours a day, every day of the year.

The tools used to diagnose and stabilize patients in acute psychiatric distress include:

- Detailed interviewing and multi-modal data gathering.
- Thorough medical evaluations to rule out neurovascular problems, adverse reactions to medications, and other diseases and disorders whose symptoms might appear to be psychiatric in origin.
- New psychotropic medications to alleviate psychological pain.
- Crisis counseling skills to provide immediate coping strategies to help the patient deal with psychosocial stressors contributing to admission to the PED.
- Discharge planning and referrals to appropriate inpatient or outpatient services.

Long Island Crisis Center 516-679-1111

Long Island Crisis Center provides free, confidential, and non-judgmental programs and services to support and empower Long Islanders at critical times in their lives. They provide short-term crisis counseling, suicide prevention, information, and referrals on a wide range of issues through their 24-hour, seven-day-a-week, crisis hotlines, and live online and mobile chat.

Target Population:

Adults, over 18, presenting in a mental health crisis, but do not necessarily require the services of an emergency room.

The Adult Behavioral Health Crisis Center, part of Zucker Hillside Hospital's Adult Outpatient Psychiatry Department, is a walk-in clinic that provides individuals with short-term psychiatric services and connects them to long-term care. With a multidisciplinary team of psychiatrists, nurse practitioners, medical assistants, social workers, care coordinators and peer advocates, they are equipped to provide psychotherapy, referrals for outpatient care, and prescriptions for medication (as needed). The program is open Monday through Friday, 9am to 3pm.

Cohen Children's Pediatric Behavioral Health Urgent Care Center – Walk-in Clinic 269-01 76th Avenue New Hyde Park, NY 11040 **718-470-3148**

Target Population:

Children and adolescents, age 5-17, presenting in a mental health crisis, but do not necessarily require the services of an emergency room.

The Cohen Children's Pediatric Behavioral Health Urgent Care Center provides timely access to pediatric mental health services for children and adolescents (age 5-17) presenting in a mental health crisis. The program is designed as an alternative treatment setting for those who need urgent (same day) intervention, but do not necessarily require the services of the emergency room. (If the child does need the emergency room for a mental health issue, they should go straight to the emergency room.) The program is open Monday through Friday, 9am to 3pm.

Inpatient Hospitals – Mental Health

A 24-hour inpatient treatment program that is a place for people in need of treatment for severe mental disorders. Psychiatric hospitals are built and designed to be safe environments for patients to receive intensive treatment for their mental health conditions.

Inpatient Programs – Substance Use

Inpatient programs provide a safe and supportive setting for the evaluation, treatment, and rehabilitation of people with substance use disorders. These facilities offer 24-hour, 7-day a-week care that is always supervised by a medical professional. Inpatient services include intensive management of symptoms related to addiction and monitoring of the physical and mental complications resulting from substance use.

Medically Managed Detoxification

Crisis services provide a variety of treatment options designed to provide immediate care for people who are intoxicated or incapacitated by their use of alcohol or other substances. The primary goal of these services is to manage withdrawals from substances, as well as medical and psychiatric complications during withdrawals. Crisis services include detox services and are also designed to facilitate connections to continued care.

Nassau University Medical Center - Chemical Dependency Detoxification (Detox) Unit 2201 Hempstead Turnpike East Meadow, NY 11554 516-572-6394

The Detox Unit at Nassau University Medical Center helps people safely withdraw from alcohol, opiates, and other addictive drugs in a controlled medical environment. Along with medically managed detoxification, patients are educated about addiction, with stress on detoxification as only the first step in treatment. On average, patients' complete detox in five days, but all treatment plans are tailored to best facilitate everyone's own process of recovery.

OASAS Residential Programs

Residential services are designed for people who need support in their recovery and may not be able to participate in treatment without a 24-hour residential setting. Residential services are designed to develop or maintain recovery through a structured, substance-free setting, and can include group support, skills development related to independent living, and other services designed to promote recovery.

<u>Population Served</u>: Adult women above the age of 18 that report significant difficulty managing life due to substance abuse. Mercy Hall is a reintegration residential facility for women who are in recovery from alcohol and/or substance dependence who have made the choice live a sober life. The program includes counseling, rehabilitative, and vocational services. The average length of stay ranges between 8-12 months; however, this can be individualized based on circumstances and needs. The program is designed to educate individuals on how to balance a productive, successful life and recovery.

<u>Population Served</u>: Adult men above the age of 18 that report significant difficulty managing life due to substance abuse. Recovery House is a reintegration residential facility for men who are in recovery from alcohol and/or substance dependence who have made the choice live a sober life. The program includes counseling, rehabilitative, and vocational services. The average length of stay ranges between 6-9 months; however, this can be individualized based on circumstances and needs. The program is designed to educate individuals on how to balance a productive, successful life and recovery.

<u>Population Served:</u> Adults 18 years of age and older, who present with a primary diagnosis of substance use disorder. New Hope is a Stabilization Program offering protective, short-term residential care to adults who present with a primary diagnosis of substance use disorder. In addition to providing services for individuals with primary substance use disorder, services are offered for adults presenting with associated mild to moderate withdrawal symptoms or who are diagnosed with co-occurring mental health concerns as well as those experiencing situational crises because of substance use disorder. The goal is to stabilize the individual in an environment that is safe, sober, and therapeutic in nature. Once stabilization is achieved, New Hope will continue to assist the recovering individual with an appropriate referral and transportation to the next level of care.

<u>Population Served</u>: Individuals over the age of 18 who have a designated substance use disorder/chronic addiction, who are high-cost frequent consumers of Medicaid benefits and are homeless or at risk of returning to homelessness. Must have a history of two inpatient hospitalizations; OR at least five emergency room episodes; OR a combination of four emergency room episodes and one inpatient hospitalization in a 12-month period. This program provides permanent housing to individuals in a single apartment. The program is a collaboration with Mercy Behavioral Health Services where program recipients can receive ongoing clinical care. SAIL's OASAS Program ensures the provision of community integration and provides support services to assist individuals in their recovery and integrating into the community. This includes working on achieving goals and maintaining housing.

<u>Population Served:</u> Adults, over age 18, in a psychiatric crisis not requiring inpatient level of care, who would benefit time out of their home environment. Turquoise House I and II are peer respite wellness centers that allow guests to use their crisis as an opportunity, providing connection, hope, and a successful alternative to hospitalization. Turquoise House II is a Crisis Residence. Guests stay in a comfortable, homelike environment for up to 28 days for intensive,

transformative support, served by a team of trained Peer Specialists who support, accept, and listen. Self-help mutual support is reciprocal and produces empowerment in the participants.

Crisis Respite Residential Services – Children

Children's Crisis Respite provides short-term respite residential care for Nassau County residents ages 5 - 17 in psychiatric crisis using structed and supportive crisis respite beds. The goal of the program is to provide swift crisis intervention and to foster long-term stabilization for children and adolescents in psychiatric crisis without the use of psychiatric hospitalizations or other overly restrictive placements. Referrals for the program must be submitted to the Children's Crisis Respite Coordinator through Mental Health Association (MHA).

Crisis Respite Residential Services – Adults

Crisis Respite Residential services are licensed residential (24 hours/day) stabilization program, which provide services for acute symptom reduction and the restoration of patients to pre-crisis level of functioning. These programs are time limited for persons until they achieve stabilization (generally up to 30 days). Crisis residences serve persons experiencing rapid or sudden deterioration of social and personal conditions such that they are clinically at risk of hospitalization but may be treated in this alternative setting.

Children's Psychiatric Hospital Discharge Planner

The Children's Hospital Discharge Planner is available for any Nassau County residents under the age of 21 who are hospitalized psychiatrically. Please note, the youth does not need to be inpatient at hospital located in Nassau County to be eligible, they just need to be a resident of Nassau. The goals of the Children's Hospital Discharge Program are to shorten hospital stays by transitioning to appropriate community supports, avoid re-hospitalization and psychiatric emergency room visits through the provision of appropriate community mental health resources. The program provides consultation to hospital staff to ensure adequate discharge planning, provides individualized planning and service coordination, and transitions children and adolescents to appropriate mental health resources including follow-up services.

This program provides short-term, intensive home-based services to families to prevent the psychiatric hospitalization of a child or adolescent. Over a 4–6-week period the objective is to resolve crisis situations, enhance family functioning, promote self-sufficiency, assist in keeping families together, and linkage to community-based supports.

Residential Eating Disorder Treatment

This adolescent treatment facility partners with Learn well for education consultation so patients can stay on track with their education and learning while in treatment. Treatment modalities offered include cognitive behavior therapy (CBT), exposure & response prevention (ERP), and dialectical behavioral therapy (DBT).

<u>Population Served:</u> Individuals over age 18 who are struggling with an eating disorder. An adult residential eating disorder program focuses on the restoration of physiological and nutritional balance, implementation of healthy eating and exercise routines, elimination of harmful behaviors, and development of motivation and treatment engagement. The objective is to help each client achieve a clear understanding of their eating and/or exercise disorder and its effect on their life, as well as an individualized appreciation of what is necessary for their personal recovery.

Opioid Treatment Programs

Opioid Treatment Centers (OTP) are OASAS-certified sites where medication to treat opioid dependency is administered. These medications can include methadone, buprenorphine, and suboxone. In addition to medications, these facilities also offer counseling and educational services. In some cases, patients receiving services at an OTP clinic are provided treatment over a lifetime, like management of chronic physical ailments. Medications can also be used in the short-term to reduce withdrawal symptoms and cravings in the earliest stages of recovery.

Substance Use Outpatient Treatment (OASAS)

Outpatient facilities provide clinical services for people with an addiction to substances and their families who have been impacted by their addiction. These services include counseling, education, and connections to community services. Modalities offered may include individual therapy, group therapy, medication management, peer specialists, Medication Assisted Treatment (MAT), education about addiction and community supports, drug awareness, and relapse prevention. Family members and loved ones of those struggling with substance use are also eligible for services.

OMH Outpatient Partial Hospitalization

A partial hospitalization program is a program for adults or adolescents which provides active treatment designed to stabilize or ameliorate acute symptoms in a person who would otherwise need hospitalization. "Partial" refers to the fact that treatment is provided in a highly structured environment, but only during the day.

A partial hospitalization program shall provide the following services: assessment and treatment planning, health screening and referral, symptom management, medication therapy, medication education, verbal therapy, case management, psychiatric rehabilitation readiness determination and referral, crisis intervention services, activity therapy, discharge planning and clinical support services. The program can be used to ease transition following an inpatient psychiatric hospitalization or to avoid an admission.

OMH Personalized Recovery Oriented Services (PROS)

Personalized Recovery Oriented Services (PROS) is a comprehensive recovery-oriented program for individuals with severe and persistent mental illness. The goal of the program is to integrate treatment, support and rehabilitation in a manner that facilitates the individual's recovery. Goals for individuals in the program are to improve functioning, reduce inpatient utilization, reduce emergency services, reduce contact with the criminal justice system, increase employment, attain higher levels of education and secure preferred housing. There are four "service components" in the program: Community Rehabilitation and Support (CRS), Intensive Rehabilitation (IR), Ongoing Rehabilitation and Support (ORS) and Clinical Treatment.

<u>Population Served</u>: Individuals 18 years of age and older who have been diagnosed with a serious mental illness with a goal of recovery focused on the resumption of life roles that include their ability to socialize, maintain activities of daily living and obtain employment.

OMH Adult Single Point of Access (SPOA)

Adult SPOA (Single Point of Access) coordinates referrals for care coordination agencies and ACT Team providers. An individual receiving care coordination services can expect assistance with accessing services that support an improved quality of life. Care coordination can involve assistance with housing, outpatient treatment, vocational services, day programs and disability benefits. Additionally, the Adult SPOA unit provides referrals for care coordination services for those individuals without Medicaid coverage and is available to help as you navigate the mental health system. Clients with Medicaid may also make a direct referral to a Health Home for care coordination services.

Adult Health Home Care Management

Health Home Care Management program provides coordinated, comprehensive medical and behavioral health care to Medicaid-enrolled adults with chronic conditions. Home Health Care Management assures access to appropriate services, improves health outcomes, reduces preventable hospitalizations and emergency room visits, promotes the use of health information technology, and avoids unnecessary care. Health Home Care Managers are expected to provide comprehensive care management, health promotion, transitional care including appropriate follow-up from inpatient to other settings, patient and family support, and referrals to community and social support services. Health Home Care Managers promote optimal health and wellness for adults diagnosed with severe mental illness. Wellness and recovery goals are attained by implementing a person-centered approach to service delivery and ensuring linkages to and coordination of essential community resources.

Health Home Plus (HH+) is an intensive Health Home Care Management (HHCM) service established for defined populations with Serious Mental Illness (SMI) who are enrolled in a Health Home.

Equivalent services are available for individual who do not have active Medicaid.

OMH Adult Assertive Community Treatment (ACT) Services

A team of professionals assigned to treat, monitor and ensure outpatient continuity of care for a select group of individuals diagnosed with a severe mental illness and whose needs have not been met by more traditional mental health services. ACT Teams provide treatment, rehabilitation, case management and support services.

<u>Population Served</u>: Adults whose diagnosable mental illness significantly impairs his/her ability to function in the community without supports. ACT clients are those individuals who are generally high users of services including frequent acute psychiatric hospitalizations, emergency and/or crisis services and criminal justice involvement.

All referrals for Adult ACT services must be made through the Nassau County Department of Human Services Office of Mental Health, Chemical Dependency and Developmental Disabilities Services.

The FACT programs have a focus on providing the forensic population with targeted interventions, support services and advocacy to reduce recidivism by stabilizing their psychiatric disorder and addressing their social determinants of health needs.

OMH Assisted Outpatient Treatment (AOT)

AOT provides a court ordered outpatient treatment program designed to assure that those who cannot live safely in the community, due to their history of non-compliance and present circumstances, receive the clinical care and case management they need to safely manage in the community.

Target Population:

- At least 18 years of age and suffers from mental illness; and
- Is unlikely to survive in the community without supervision, based on a clinical determination.
- Has history of non-compliance with treatment for mental illness which has led to either 2 hospitalizations from mental illness in the preceding 3 years or resulted in at least 1 act of violence toward self or others or threats of serious physical harm to self or others within the preceding 4 years.
- Is unlikely to accept the treatment recommended in the treatment plan.
- Needs AOT to avoid a relapse or deterioration that would likely result in serious harm to self or others.

The AOT Order includes a comprehensive Treatment Plan which includes outpatient program attendance and medication management in addition to monitoring and supervision by the Nassau County Department of Human Services Office of Mental Health, Chemical Dependency

and Development Disabilities Services AOT Unit. AOT recipients will receive Care Coordination services via a Care Coordination Agency or an Assertive Community Treatment (ACT) team.

Community Oriented Recovery and Empowerment

<u>Population Served:</u> Eligible adult Medicaid beneficiaries with serious mental illness and/or substance use disorders to receive services in their own home or community. Eligibility for CORE Services is based on the individual being enrolled in a Medicaid Health and Recovery Plan (HARP), HIV-Special Needs Plan (HIV-SNP), or Medicaid Advantage Plus (MAP) Plan and the individual must meet the NYS Behavioral Health (BH) High-Risk Criteria.

CORE Services are person-centered, recovery-oriented, mobile behavioral health supports. They build skills and self-efficacy that promote and facilitate community participation and independence. CORE Services include:

Community Psychiatric Support and Treatment (CPST)

•Goal-directed supports and solution-focused interventions with the intent to achieve person-centered goals

• Multi-component service that consists of therapeutic interventions

Psychosocial Rehabilitation (PSR)

•Assists individuals in improving their functional abilities to the greatest degree possible in settings where they live, work, learn, and socialize

•Rehabilitation counseling, skill building, and psychoeducational interventions

Family Support and Training (FST)

•Offers instruction, emotional support, and skill building necessary to facilitate engagement and active participation of the family

•FST partners with families through a person-centered or person-directed, recovery oriented, traumainformed approach

Empowerment Services – Peer Support

•Non-clinical, peer-delivered services with focus on rehabilitation, recovery, and resilience

•Promotes skills for coping with and managing behavioral health symptoms while facilitating the use of natural supports and community resources

OMH Single Point of Access (SPOA) for Children

The Children's SPOA assists in linking children with serious emotional disturbance to services that can assist in meeting their needs. The Children's SPOA is characterized by a multi-disciplinary representation of agencies. Referrals may be made to SPOA for children, age five through some to 21, with a psychiatric diagnosis who meet the NYS OMH criteria for Serious Emotional Disturbance (SED). The aim is to ensure appropriate access to both intensive in-home services and residential services. The Children's SPOA Coordinator provides case consultation, systems navigation, referral, and linkage to mental health supports and services.

<u>Population Served</u>: Children and adolescents ages 5 through 21 who are diagnosed with a Serious Emotional Disturbance (SED), have private insurance or no insurance, and live in Nassau County. This program serves clients who are typically medium to low acuity.

The Non-Medicaid Care Coordination program supports children with a Serious Emotional Disturbance (SED). Care coordination services may include linkage to needed services, monitoring established goals and outcomes, and providing case specific advocacy to help ensure the child is able to remain at home and within the community upon discharge. Services include comprehensive care management, coordinating with service providers and clinicians to ensure changes in treatment are addressed, crisis intervention, advocating, collaborating with other providers, and linking to needed services and supports.

<u>Population Served</u>: Children and adolescents up to age 21 who reside in Nassau County and are at risk of hospitalization or out-of-home placement due to their Serious Emotional Disturbance (SED).

This is an intensive in-home program, includes a multidisciplinary team of mental health professionals, care coordinators and youth peer advocates to provide youth and their families or caregivers with education, tools and skills to better handle situation. The Home-BEST team also coordinates with the youth's school and clinical supports to effect better outcomes and connects the families to community resources to assist in meeting their unique needs.

<u>Population Served:</u> Children and adolescents up to age 21 who have a Serious Emotional Disturbance (SED) and reside in Nassau County. Children demonstrate or have a history of being at high risk including, but not limited to, the following be at substantial risk of out of community placement such as hospitalization and/or residential placement; school avoidant; non-compliant with medication; whom traditional outpatient services have not been effective.

This program provides in-home and/or community based clinical services, including individual therapy, family therapy, and psychiatric consultation, evaluation, and monitoring with a goal of engaging the child to outpatient treatment or a lower level of care. Children involved usually refuse to participate in therapy, often are school avoidant, and frequently have limited social contacts.

<u>Population Served:</u> children and adolescents up to age 21 with a Serious Emotional Disturbance (SED) diagnosis with current multi-system involved (e.g. family court, Individual Education Program, juvenile justice, Person in Need of Supervision (PINS), Child Protective Services, etc.) This program provides care coordination which facilitates service delivery, including acquiring benefits, helping children/families make and keep appointments and assisting them in arranging needed behavioral health, physical health, and psychiatric rehabilitation services. This program also seeks to find appropriate school placements, vocational training, or employment as well as linkages to services that prevent or resolve crises and addresses social determinants of health (SDOH) needs. Staff help families learn skills needed to avoid use of emergency rooms and/or inpatient services. They also provide psychoeducation on resources available and how to access them, enabling children and families to move toward self-sufficiency and self-advocacy.

Children's Health Home Care Management:

<u>Population Served</u>: Individuals up to age 21 who have active Medicaid that have been diagnosed with a serious emotional disturbance (SED), complex trauma, HIV/AIDS or two chronic health conditions (i.e., asthma, diabetes, heart disease, high blood pressure, substance abuse, or obesity).

Care Management works with the child/family and providers of services to identify service needs, developing an overall rehabilitation goal, and writing service plans with the child/family that include strategies and objectives to address their identified needs. Care management facilitates service delivery, including acquiring benefits, helping child/families make and keep appointments and assisting child/family in arranging needed behavioral health, physical health and psychiatric rehabilitation services and finding appropriate school placement, vocational training or employment. Services also provide linkage to services that prevent or resolve crises to prevent unnecessary use of emergency rooms and/or inpatient services, and assuring crisis intervention services 24 hours per day, 7 days/week.

Home and Community Based Services (HCBS)

<u>Population Served</u>: Children and adolescents up to age 21 with active Medicaid who are eligible for Health Home Care Management services and are at risk of hospitalization or out of home placement may be eligible for HCBS services.

HCBS provides a system of care that accounts for the strengths, preferences, and needs of the individual, as well as the desired outcome. The array of services helps children remain in their community and avoid higher levels of care and out-of-home placements. HCBS for children include the following: caregiver/family supports and services, community self-advocacy training and supports, respite (planned and crisis), prevocational services, supported employment, day/community habilitation, palliative care, environmental/vehicle modifications, adaptive and assistive equipment.

Residential Services

Community Residences (CR):

Community Residences are 8-bed residential programs for children that provide an intensive therapeutic environment and restorative services including but not limited to behavior management, counseling services, independent living skills, daily living skills, socialization skills, medication management, health services and family support services. The goal of the program is to teach the youth necessary skills to be able to successfully return home with their families and communities. Program staffing provides for 24-hour awake supervision.

Residential Treatment Facility (RTF):

Residential Treatment Facilities provide fully integrated mental health treatment and special education services under the direction of a psychiatrist, in a well-supervised residential setting. RTFs can serve youngsters between 5 and 21 years of age. Most youngsters are served for an extended stay between 6 months and 2 years. Access to an RTF is through the Authorization Review Process under the guidance of the Office of Mental Health.

OMH Youth Assertive Community Treatment (ACT) Services

Youth ACT teams deliver intensive, highly coordinated, individualized services and skilled therapeutic interventions through an integrated, multidisciplinary team approach. Youth ACT services are delivered in the home or other community-based settings. The purpose of Youth ACT is to support children with complex mental health needs and their families so that they may remain in their homes and communities, achieve success in their educational, vocational or employment endeavors and foster positive relationships among friends and family.

<u>Population Served</u>: Children and adolescents ages 10 to 21, who are diagnosed with a Serious Emotional Disturbance (SED) who have continuous high service needs that are not being met in more traditional service settings. The children are at risk of institutional level of care, require intensive interventions to adequately support the child and family's complex needs, to avoid high end services or facilitate and support a successful transition back to community.

Children and Family Treatment and Support Services (CFTSS)

<u>Population Served:</u> Children and Youth (under age 21) who are covered by Medicaid and have mental health and/or substance use needs may be eligible for Children and Family Treatment and Support Services. These services meet the individual needs of children/youth and their families/caregivers in their home and community. They can help identify mental health and/or substance use needs early, provide support in the home and community, prevent the need for emergency room visits, hospital stays, or out of home placements.

Services Include:

Other Licensed Practitioner

Provides evaluation/assessment, treatment planning, psychotherapy, and crisis intervention in non-traditional settings, including home, community, and other site-based setting when appropriate.

Crisis Intervention

Mobile services provided to youth who are identified as experiencing acute psychological/emotional change which results in an increase in personal distress and exceeds the ability of those involved to effectively resolve it. Face-to-face interventions and face-to-face or in person follow up.

Community Psychiatric Supports and Treatment

Designed to provide community-based services to children and families who may have difficulty engaging in formal office settings. Includes intensive intervention (individual and family counseling, behavior management support), crisis avoidance and crisis management, education about treatment options based on needs, strengths-based service planning and support for physical health and safety.

Psychosocial Rehabilitation

Hands on, task-oriented activities focused on rehabilitative needs of the youth which are usually provided in the community, including the home. Includes interventions to work on personal and

community competence, social and interpersonal skills, daily living skills, and community integration.

Family Peer Support Services

Provides a structured, strength-based relationship between a Family Peer Advocate (FPA) and the parent/family member/caregiver for the benefit of the child/youth. Includes engagement, bridging and transition support, self-advocacy, self-efficacy, and empowerment; parent skill development, developing community connections and natural supports.

Youth Peer Support and Training

Engagement, support, community connection, and skill building from a credentialed Youth Peer Advocate professional, who has experience(s) in the service system.

Mental Health Adult Housing – Single Point of Access (SPA) Housing

Single Point of Access (SPA) is committed to providing housing to Nassau County residents with serious behavioral health issues regardless of race, creed or color, to promote recovery through a strength-based support system. The SPA strives to reduce stigma and provide opportunities for recovery and is responsive to individual recipient wishes and needs to reduce hospitalization and homelessness.

<u>Population Served</u>: Eligibility for SPA housing is based on meeting the criteria for Serious Mental Illness (SMI) as defined by the New York State OMH. The County residence is demonstrated by current address. For non-residence, a meaningful connection to the county of interest will be considered.

There are four general levels of housing that can be applied for based on needs:

Supervised Community Residence – CR

These programs are supervised 24 hours per day. These residences typically house 8 - 15 individuals in one large house. Food is provided. Residents are offered all restorative services, generally with an emphasis on Daily Living Skills such as cooking, cleaning, personal hygiene, food shopping and money management. Medication is supervised as needed. There is also a Young Adult CR specifically available for individuals aged 18-30.

SRO Community Residence (CR-SRO)

This level offers individuals their own bedrooms usually in a large building with up to 50 residents. Staff supervision is present 24 hours per day. It is recommended that residents prepare their own meals. A meal plan may be available for purchase depending on location. Restorative services are available.

Apartment Treatment – ATP

These programs typically receive staff visits several times each week, depending on level of need. There are generally 2-3 residents per house or apartment. Residents are expected to have good daily living skills and be able to hold their own medication. Food is not provided. Instead, residents receive an allowance, which is used to purchase food and cleaning supplies. Applicants should have some ability to manage their own medications.

Supportive Housing – SHP

Supportive Housing programs vary. Programs may offer shared apartments, houses for three individual adults, or families. Individuals residing in Supportive Housing pay 30% of their monthly income toward their rent. The rest of their rent is subsidized. Residents of these programs live independently and may receive visits 1-4 times monthly. Supportive Housing is considered long term housing.

Mobile Residential Support Team

The goal of The Mobile Residential Support Team (MRST) is to improve quality of life and to promote the independence of recipients assigned to the team. The team also provides support in the community to ensure recipients can remain safely housed at the current level of care. Services provided by the team include crisis intervention, peer support, and monitoring of medical conditions to help decrease psychiatric/medical ER visits and/or hospitalizations. The MRS team also assists recipients by coordinating care between providers, connecting recipients to beneficial resources in the community, and addressing any issues that may prevent recipients from maintaining stable housing.
