Activity: CDBG-DR funds will be used to design and construct a stormwater pump station in the Village of Cedarhurst. This project is listed as a recommendation in Nassau County's Five Towns Drainage Study which was completed by AECOM pursuant to recommendations in the Five Towns NY Rising Community Reconstruction (NYRCR) Plan. The project engineer will determine the optimal location and size of the pump station needed to increase the resiliency of the Village of Cedarhurst. The pump station will be constructed to control stormwater flow during and after extreme weather events by pumping water to existing outfalls. Project implementation will result in reduced risk of chronic flooding associated with extreme high tides and storm events in residential and commercial areas within the target area, thus improving resiliency for these areas in the face of sea level rise and increasing frequency and intensity of extreme weather events.

Objective: To address the urgent need to provide drainage infrastructure upgrades to address widespread flooding resulting from Hurricane Sandy.

Location: Municipally-owned property, Village of Cedarhurst, NY

Amount: Table 1 shows the CDBG-DR activity and the corresponding dollar amount for the Cedarhurst Pump Station along with the estimate of the total project cost.
