The Nassau County Open Space and Parks Advisory Committee (the “Committee”) will hold a public meeting on Wednesday, October 9, 2024 at 4:00 P.M. in the Parks Department Conference Room located in the Parks Administration Building in Eisenhower Park in East Meadow. The meeting will be streamed lived on <https://www.nassaucountyny.gov/5694/OSPAC>. The Committee notifies the public that the meeting concerns Stillwell Park, located in Syosset, as well as Whelan

Park, located in Malverne. Specifically, the Committee will discuss a proposed Inter-Municipal Agreement for the transfer of Stillwell Park from Nassau County to the Town of Oyster Bay (Section: 14, Block: E, Lot(s): 1010) and a proposed Inter-Municipal Agreement for the transfer of Whelan Park from Nassau County to the Incorporated Village of Malverne (Section: 35, Block: N, Lot(s): 25B, 25C, 26, 27A & 27B). The Committee will issue separate recommendations regarding the proposed IMA transfers to the Nassau County Planning Commission. Additionally, the Committee will also discuss the sale of County-owned property to a homeowner located at 2499 Oak Street in Bellmore (Section: 56, Block: S-06, Lot(s): 592) and issue a recommendation regarding the proposed sale to the Nassau County Planning Commission.
