Summary of Proposed DPW Work Within Legislative District 6 – Roosevelt
01.30.2024

1. H41876-01GR - Centennial Park Rehabilitation

- a. Construction contract has started – Landtek is the Contractor. Currently they are in the submittal stage – but plan to start site work in early Spring.
- b. Total Construction Cost = \$ 4,681,324.00
- c. The scope of work involves rehabilitating Centennial Park’s infrastructure and improving the aging amenities to eliminate any safety and other concerns. Sidewalks around the perimeter of the park as well as pathways within the park are to be replaced. The basketball and handball courts will be resurfaced. The administration building will be updated and will serve as an additional park entrance point. Other improvements will include video surveillance, new vinyl fencing, viewing area with bleachers, playground laid out in age-appropriate areas, spray park, and lighting. New elements will include a walking path with exercise stations, shading structures, a mini pitch soccer field and a reserve picnic area for visiting groups.

2. H62222-01 – Nassau Road, Roosevelt Roadway Safety Improvements

- a. Currently in design solicitation. Anticipated construction start of Q3 2026.
- b. Projected Construction Cost = \$ 8,000,000
- c. This contract will allow for the design and construction of roadway and traffic calming improvements along Nassau Road from the northside of the Southern State Parkway to Pleasant Avenue. These improvements will include streetscape beautifications, entryway creation, installation and repair of sidewalks, curbs, ADA curb ramps, bulb-outs, drainage structures, tree impacts, roadway resurfacing, replacement of pavement markings, improve pedestrian safety, upgrade traffic signal infrastructure, and other incidental work.

3. H61130-01 - Babylon Turnpike, Roosevelt, Merrick, Freeport Roadway Safety Improvements

- a. Currently in design solicitation. Anticipated construction start of Q3 2026.
- b. Projected Construction Cost = \$ 13,000,000
- c. This contract will allow for the design and construction of roadway and traffic calming improvements along Babylon Turnpike from Nassau Road to Merrick Road in Roosevelt, Merrick and Freeport. These improvements will include

streetscape beautification, entryway creation, installation and repair of sidewalks, curbs, ADA curb ramps, bulb-outs, drainage structures, tree impacts, roadways resurfacing, replacement of pavement markings, improve pedestrian safety, upgrade traffic signal infrastructures, and other incidental work.

4. 41889 – Reverend Arthur Mackey Park Improvements

- a. DPW has recently completed improvements – Dream court installation, lighting upgrades etc.
- b. This new capital project will be similar to the work currently proposed at Centennial – in which the County will rehabilitate the park's infrastructure and improve the aging amenities to eliminate any safety and other concerns.
- c. DPW will be coordinating with County Parks and the Leg. office shortly to scope and schedule a community engagement meeting.

5. S80020 – Brookside Creek

- a. This project will study environmental conditions associated with Brookside creek and implement and maintained solutions.
- b. Complete watershed and creek capacity study required.
- c. Unique circumstances due to combination of public/private ownership of creek right of way.
- d. DPW is presently submitting various grant applications to subsidize the proposed work.
- e. Currently funded at \$3,750,000

6. Recently Completed Roadway Resurfacing

- a. Centennial Avenue, Baldwin / Roosevelt from DeMott Ave (w/o Woodside Ave) to Brookside Avenue
- b. West Centennial Avenue, Roosevelt from Brookside Ave to Nassau Rd
- c. Nassau Road, Roosevelt from Davis St (N. Main St.) to Centennial Ave & from Lakewood Ave. to Southern State Parkway

7. Recently Completed Tree Plantings

- a. Total of 15 new trees were planted last Fall at the following locations:
 - i. 67 W. Pennywood Avenue SIDE – 2 Okame Cherry
 - ii. 590 Brookside Avenue – 1 Okame Cherry
 - iii. 96 W. Clinton Avenue SIDE – 1 Okame Cherry
 - iv. 530 Brookside Avenue – 2 Okame Cherry
 - v. 442 Brookside Avenue – 1 Okame Cherry
 - vi. 1153 Cramer Court SIDE – 1 Okame Cherry
 - vii. 1154 Cramer Court SIDE – 1 Okame Cherry
 - viii. 426 Brookside Avenue – 1 Okame Cherry
 - ix. 389 Brookside Avenue – 2 Okame Cherry
 - x. 365 Brookside Avenue – 2 Okame Cherry
 - xi. 1111 Alhambra Road SIDE – 1 Okame Cherry
