RE: Simplified Reports

The reports issued by the Division of Forensic Services are required by accreditation standards found in ISO/IEC 17025:2017 to contain specific content. When agreed with the customer, accreditation requirements allow for the issuance of simplified reports. To maintain the format of the Laboratory Report(s), the applicable requirements and the laboratory's proposals in the table below will be the terms of this agreement. By utilizing the laboratory's services, you acknowledge and agree to the following in relation to the format of the laboratory report.

	deviations, or exclusions from laboratory methods. If these
	occur, they will be documented in the case record.
