Board of Health

The Nassau County Board of Health and the Nassau County Department of Health were created in 1938 by the Nassau County Charter.

Members of the Board of Health (hereafter referred to as the "Board") are appointed by the County Executive to five-year terms. The Board enforces the New York State Public Health Law as well as New York State and local sanitary codes.

The Board is authorized to:

- Prescribe the duties of and direct the Commissioner of Health.
- Make and publish orders and regulations for the preservation of life and health.
- Create orders and regulations for the supervision of nuisances and other matters detrimental to public health.
- Restrain by injunction violators of its orders and regulations.
- Issue subpoenas, compel the attendance of witnesses, and administer oaths and compel testimony.
- Issue warrants to peace officers to enforce the law.
- Prescribe and impose penalties for violations of, or failure to comply with, its orders or regulations or any of the regulations of the state sanitary code.

Department of Health Mission


Nassau County Department of Health promotes and protects the health of all who live, work, and play in Nassau County.

- Prevention of environmental health hazards through assessment, regulation, and remediation.

- Provision for evaluation and services to individuals, children, and families that have developmental delays and concerns.

Departmental Structure

The Board of Health is the governing body of Nassau County Health Department (NCDOH), overseeing the Commissioner of Health. In March of 2023, NCDOH underwent a restructuring. The Offices of Public Health Legal Affairs, Communications, Health Equity, and Epidemiology, Biostatistics, and Planning report directly to the Commissioner. The Divisions of Public Health Emergency Preparedness, Communicable Disease Control, Environmental Health, Maternal Child Health Services, Community Outreach, and Public Health Laboratories are under the leadership of the First Deputy Commissioner of Health. The Deputy Commissioner for Administration oversees the Bureau of Fiscal Management and the Bureau of Human Resources.



NCDOH HIGHLIGHT OF 2023:

CDC Director Mandy K. Cohen Comes to Town!

In November, NCDOH hosted Nassau County native and CDC Director Mandy K. Cohen. She along with Commissioner Irina Gelman and the NCDOH Division Directors visited Nassau University Medical Center, Nassau County's public-benefit hospital. Director Cohen shared tips on how to stay well and recommended that everyone stay up to date with their Flu and Covid-19 vaccines. Director Cohen, Commissioner Gelman, and NCDOH Division Directors also toured the South Shore Water Reclamation Facility to showcase the pioneering Wastewater Surveillance Program work, piloted this year and on track for

expansion within 2024.

NCDOH HIGHLIGHT OF 2023:

Reaccreditation Efforts

In 2017 NCDOH was granted accreditation status by the Public Health Accreditation Board (PHAB), a national organization which evaluates local health departments based on 10 Essential Public Health Services. Accreditation status is valid for 5 years after which, reapplication is necessary. In 2023, NCDOH began the process of applying for Reaccreditation. This is an extensive, rigorous process of gathering and submitting documentation to demonstrate satisfactory fulfillment of the 10 Essential Public Health Services, depicted in the graphic on the next page. There were 10 domains comprised of 55

measures in the Standards and Measures for Reaccreditation that needed to be addressed. This resulted in more than 400 documents. PHAB will review submission in 2024.





Bureau of Human Resources

From 2022 to 2023, NCDOH experienced considerable growth in total number of employees. In 2022, NCDOH ended the year with 191 total employees, and in 2023, NCDOH ended the year with 218 total employees. This represents a 14.1% increase in the total employees over the course of the calendar year. The chart to the right shows the breakdown of total employees for the years 2022 and 2023, whether they were full-time or part-time, and if they were paid by the general or grant funded. Also, in 2023, the NYS Public Health Corps Fellowship Program launched, providing additional staff support.

- Drafting Departmental Policies, Commissioner's Orders, and local public health ordinances
- **❖** Training all staff members on HIPAA and confidentiality issues during onboarding process and refresher sessions
- **Responding to subpoenas and Freedom of Information Law requests**
- Conducting legislative review for purposes of evaluating potential impacts on laws on public health efforts, response, and protection of our residents
- **Assisting staff with archiving documents and other materials**



- 3. Designate a safe storage spot for cannabis products.






Public Health Campaign: Tick Surveillance



Division of Communicable Disease Control

The Division of Communicable Disease Control protects the public from the spread of diseases through surveillance, investigation, intervention, and education. It is comprised of four Bureaus – Tuberculosis Control, STD/HIV Control, and Perinatal Hepatitis B and Immunization, and Disease Control.

2023 Disease Activities:

- Over 4,500 Communicable Diseases (excluding influenza and Covid 19) reported and confirmed
- **❖** 45 TB cases confirmed and case managed
- ❖ Over 5000 STD cases (including MPOX) confirmed and investigated
- **❖** 107 HIV cases tracked
- Responded to Pertussis and Cyclospora outbreaks
- **TB** Control responded to worksite and school contact investigations
- **❖** Varicella and RSV became reportable in December 2023
- **❖** Triple Threat − RSV, COVID-19, and Influenza − lead to increased numbers and bad respiratory disease season in the fall
- Worked with school districts who had students that had fraudulent vaccine records from Wild Child Pediatrics
- Recommended Post-Exposure Prophylaxis for over 420 animal bites

Immunization Efforts:

2023 saw the continuation of an immunization media campaign promoting vaccinations. The campaign specifically targeted the underserved communities in an effort to increase vaccinations. Initially begun in December 2022, the campaign ran the below advertisement on 100 NICE buses throughout Nassau County. The Department works to support school efforts to ensure a vaccine-protected student population.



Division of Community Outreach

Division of Environmental Health

The Division of Environmental Health (DEH) protects the community from adverse health effects resulting from environmental pollution, unsanitary conditions or unsafe practices by regulation and enforcement of environmental health programs. DEH is comprised of the following four bureaus: Bureau of Enforcement and Permit Administration, Bureau of Environmental Engineering and Water Supply, Bureau of Food, Recreation, and Community Sanitation, and Bureau of Hazardous Material Storage, Lead, and Vector Borne Diseases.

DEH is responsible for the following:

Regulating the safe and sanitary conditions of public water systems, food service establishments, residential environments, children's camps, public pools and beaches, tattoo/body art facilities, and temporary residences

- Certifying food managers, tattoo and body piercing artists
- **❖** Monitoring the abatement of lead hazards, preventing the sale of tobacco products to minors, investigating complaints of rodent and insect infestations, and conducting mosquito and rabies surveillance.
- Reviewing and approving engineering plans for water systems, public pools, residential developments of five lots or more, and commercial development in non-sewered areas

2023 At A Glance:

- The online Food Manager's Training Course was re-instated. https://app.nassaucountyny.gov/health/fmtc/index.php
- **❖** A link was added to the NCDOH website to allow the public to view partial facility information on Petroleum Bulk Storage.
- **❖** DEH worked with NYS DEC to prepare for the new Petroleum Bulk Storage code.
- Sanitarians surveyed and provided guidance regarding roadway and pipe damage from sinkhole emergencies.
- **❖** DEH participated in initial plans with consultants for the International Cricket Council, planned for June 2024 at Eisenhower Park.
- **❖** DEH began developing a new Tick Surveillance Program
- Staff assisted Town of North Hempstead with an animal vaccination clinic; 40 dogs and 11 cats were vaccinated.
- ❖ DEH was involved in a joint investigation with the Division of Communicable Disease Control and the Office of Epidemiology, Biostatistics, and Planning in a Cyclospora outbreak

Animal Bites – New Reporting System:

In 2023, NCDOH, with the help from County IT, revamped its method of animal bite reporting, switching from paper to electronic reporting. Animal bite incidents are to be reported immediately to NCDOH and starting in February, the reports were submitted electronically. This can be done by scanning a QR code or filling out the app on the Department's website (https://app.nassaucountyny.gov/health/abr/index.php) This new reporting system has proven to be very efficient and streamlined.

Division of Maternal Child Health Services

The Division of Maternal Child Health Services is comprised of the following: Office of Children with Special Needs, Women, Infants, and Children's Program (WIC), Hewlett House, Childhood Fatality Review Team, and the Childhood Lead Poisoning Prevention Program.

All About Maternal Child Health Bervices:

❖ Office of Children with Special Needs (OCSN) ensures services to children with developmental delays; Early Intervention (EI) from birth to 3-years-old and Preschool Program for 3−5-years-old. The Children and Youth with Special Healthcare Needs grant provides education, information and referrals for special

needs services to families of children from birth to 21.

Women, Infants, and Children Program (WIC) provides an EBT card for food and formula as well as peer counseling to support breastfeeding women, and nutrition education for eligible pregnant/post-partum women, infants and children.

- Child Fatality Review Team reviews fatalities of residents ages 0-17 years whose death is unexpected/unexplained. NCDOH is one of two County Health Departments certified by the State to conduct these reviews. The Cribs4Kids program is an example of a preventive strategy resulting from these reviews.
- ❖ The Childhood Lead Poisoning Prevention Program provides medical case management for children with elevated blood-lead levels. It works in close partnership with Environmental Health to identify and abate hazards.

2023 Happenings:

- ❖ In July, the EI Program celebrated their 30th anniversary.
- **❖** EI and Preschool Programs implemented and trained staff on Axiom, a new electronic records system. The EI and Preschool Programs are now completely paperless.
- **❖** WIC was awarded the next 5-year contract by the State Health Department and assigned a caseload of 5,000.
- **WIC** continues to partner with NUMC for the incorporation of peer breastfeeding counselors into the program.
- **❖** The Lead Program received 38,003 lead tests for 2023. There were 355 tests identifying elevated lead levels of ≥5.0 mcg/dL 34% of these tests with levels of >10.0mcg/dL.
- Child Fatality Review Team and Cribs for Kids was approved for the next 5-year grant cycle.

Division of Public Health Emergency Preparedness (PHEP)

Since 2002, the Public Health Emergency Preparedness (PHEP) cooperative agreement has provided assistance to public health departments across the nation. This helps health departments build and strengthen their abilities to effectively respond to a range of public health threats, including infectious diseases, natural disasters, and biological, chemical, nuclear, and radiological events. Preparedness activities funded by the PHEP cooperative agreement specifically target the development of emergency-ready public health departments that are flexible and adaptable.

What Does PHEP do?

- Coordinates the response to any emergency or disaster with a public health impact on the residents of Nassau County
- **❖** Manages approximately 1,651 volunteer Medical Reserve Corps (MRC) members and provides about 25 trainings per year to DOH staff and MRC volunteers
- ❖ Oversees the NCDOH Logistics Team, which helps to maintain equipment and supplies, pack, transport, set up, and demobilize; as well as staff events and emergency responses
- **❖** Maintains more than 400 pieces of equipment, and a large supply of consumables in addition to medical supplies
- ❖ Staffs the Emergency Support Function (ESF) #8 at the Nassau County Emergency Operations Center (EOC) that coordinates with healthcare facilities and providers during an emergency

2023 Highlights:

❖ In March, PHEP conducted a Point of Dispensing (POD) Logistics exercise to test our ability to set up multiple, simultaneous POD sites.



- **❖** Managed the COVID-19 Homebound Vaccination Program with three partners resulting in 98 vaccinations administered to 76 Nassau County residents.
- **❖** Facilitated a CHEMPACK training, with colleagues from Nassau University
 - Medical Center and the Nassau County Police
 Department Homeland Security for Nassau
 County Emergency Medical Services
 personnel. CHEMPACKs are containers of
 nerve agent antidotes placed in secure
 locations throughout the County.



❖ Provided medical support at the Long Island Marathon, the Nassau County Games

for the Physically Challenged, and the Long Island Fair. NCDOH medical and logistics staff work alongside our MRC volunteers at all events.





Division of Public Health Laboratories

- **❖** NCDOH Public Health Laboratory is a NYS ELAP certified laboratory conducting chemistry/microbiology/quality assurance-quality control activities.
- **❖** The lab monitors the quality of beach and potable drinking water and the efficacy of wastewater treatment (Ex: Lead in drinking water)
- **❖** The lab performs chemical agent analyses (volatile and semi-volatile) in water, air, soil, including lead dust samples.
- **❖** The lab identifies mosquito species for West Nile and EEE (Eastern Equine Encephalitis) Virus testing.
